Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Parents and school community members were involved through a "Town Hall" style meeting remotely via Zoom on Wednesday, April 28, 2021. Input was solicited through the meeting and through use of a follow up survey (Survey Monkey) to all district families on April 29. Teachers and school staff were included in several ways. Negotiations sessions with employee representatives included discussion of strategies. All district staff were encouraged to provide input through a district-wide meeting on Wednesday, April 21, 2021 at which break-out groups discussed strategies and made specific recommendations to be included in the plan.

A description of how students will be identified and the needs of students will be assessed.

Students will be identified through teacher and staff recommendations, as well as through data analysis from formative and summative assessments (NWEA MAP program, DIBELS, CAASPP, ELPAC, etc).

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

After approval by the Board of Trustees, the Extended Learning Opportunities plan will be made available to the community by posting on the district website after approval by the Board of Trustees. Invitations to specific opportunities for supplemental instruction and support will be made based on teacher recommendation and assessment identification. Use of ParentSquare will facilitate communication regarding these supplemental services.

A description of the LEA's plan to provide supplemental instruction and support.

The following supplemental instruction and support will be provided to students in the Buellton Union School District. These extended learning opportunities will be coordinated and facilitated by a new position in administrative support, the Learning Coordinator (categorically funded for one year out of ELO grant funding):

- Summer School--aligned with Extended School Year (ESY) Special Education session.
- Tutoring support--in-person and remote (Before and after school programs)
- Community Learning Hubs--each site will host students with learning and technology support
- Assessment--On-going diagnostic, progress monitoring, and benchmark assessments of student learning (using NWEA MAP, etc.)
- On-going, specific professional development for all school staff in trauma-informed practices and support for social-emotional health and academic needs. In the 2021-2022 school year, all staff will participate in training related to trauma-informed practices (RULER Institute). This training promotes the development of five key emotional skills: recognizing, understanding, labeling, expressing, and regulating emotions. Along with the full-time Counselor on staff, supplemental counseling will be provided through a contract with a community partner to support students' mental health and well-being.
- Health support through continuation of Health Aide positions as each site.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

All federal and state relief funds are being coordinated to supplement and support existing programs. All resources have been reviewed to ensure compliance with spending guidelines, and are being carefully tracked to accomplish the goal of fully re-opening schools for in-person instruction under Public Health guidelines, enhancing academic, social and emotional supports for students and staff, and prioritizing extending learning opportunities for all students since all have been impacted by the pandemic.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
