V. Public Comments/Staff Comments

Four public comments were received. They are as follows:

It's time. We have a Superintendent who said he would step down if the merger with Vista didn't happen so we wouldn't be left with his outrageous salary package. The merger didn't happen and yet he's still here and still collecting an enormous paycheck. Why? We have educators who have worked for nearly two years without a contract. This year they earned their weight in gold by turning on a dime and switching to distance learning and keeping the kids engaged and enthusiastic. Yet they still are the lowest paid educators in the county.

It's time for a change. It's time to do the right thing. It's time to provide these powerful and vital educators with a FAIR contract with the small raise they're asking for. Throw some better medical their way, we are living through a pandemic after all. Dr Haggard, it would go a long way towards repairing some of the trust you've broken by standing by your word. Reduce your salary so the people engaging with the family and the students don't have to struggle to make ends meet. A good leader makes sure the troops are looked after BEFORE rewarding himself. Show us you're the leader you say you are.

Members of the board and attendants, hello and thanks for the opportunity for public comment. I am a parent of two children in the Buellton District. As of Monday, 6/22, we the parents are into week 3 of summer break and have experienced radio silence from the District as it relates to the upcoming 2020/2021 academic year. As plans are announced in other school districts, parents of our District are completely in the dark. Parents need and deserve communication in the form of regular updates, opportunities to provide input and concerns, and a higher level of transparency overall.

We have so many questions, and no way to even ask them. Here are a few:

-With regards to the COVID-19 pandemic, what state and/or local criteria must be met or what sorts of virus thresholds must be maintained for our district schools to be allowed to re-open for onsite instruction in August?

- -What is the current likelihood that the schools will be allowed to re-open? When will the district make the final call on this (i.e. on-site instruction, versus all distance learning, versus some hybrid of the two)?
- -What agencies or parties are dictating any required COVID 19 risk prevention strategies to be implemented when schools do re-open? What is a rough estimate of the cost of meeting the required mandates?
- -What risk prevention strategies are already in motion in the District, if any? How much money has been spent so far in this endeavor?
- -What COVID-19 risk prevention and education strategies are currently in discussion at our school district? Who is participating in any such discussions, and when and how often have they (or will they) occur? Who are the ultimate decision makers for some of the major changes we will inevitably enact in the 2020/2021 school year because of the pandemic? What are some of the key highlights of any such discussions? With regards to proposed COVID 19 risk prevention strategies being considered and discussed within our District, what kinds of metrics, scientific data, professional input, and statistics are informing any such discussions?

I acknowledge the extent to which District administrators and staff simply don't have concrete answers yet for parents, but we deserve to know at least the direction things appear to be taking and in turn, an opportunity to shape the actions we collectively take. To give an analogy, a caregiver will take a patient's temperature. The temperature does not give the full & complete picture, but it does still inform the caregiver in many important ways. So too, we parents want a "temperature" in the form of regular updates for the 2020-2021 school year in our district. The absence of this prevents parents from crucial planning, from giving our input, and restricts informed choices.
