As a mother of one child at Oak Valley and one at Jonata, I would like to ask the School Board to think hard about the decision to apply for a waiver to begin classes in person again. As a high-risk family for Covid-19 complications, I cannot risk sending my children to school and I know many others in the same situation. As much as I would love for my kids to see their friends and learn in-person, this is not possible for us. There are many families who are high-risk who cannot afford to homeschool their children with costly programs in lieu of distanced learning. I write to you today to ask you to offer a full distanced-learning option for those families that cannot take the risk but also can not afford alternate options of schooling. I understand that is more work for the teachers and we appreciate all they do for our families. This effort will surely save lives and ease the stress for little ones that cannot go back to school in-person and do not want to be forced to risk their health, or the health of family members, unnecessarily.

Also, I would like to know why my three phone messages and 2 emails last year went unanswered by Superintendent Haggard's office?

From Adriana Palacios:

Here is my comment question for the board meeting!

I understand that as of today our school has yet to apply for the County waiver, therefore. I don't see a plan in place for our school to re-open next month, even if it's just for a few days of in person instruction. According to the news our county is still on the purple tier as of today, what does that mean for your opening-plans? Are you waiting for the county to drop down to the red tier, and when it does, how long before you have kids back on campus? Is there even a possibility to go back at least the two days a week if our county is on the red tier or is our school waiting to re-open until there's a vaccine available because of liability concerns? What happens if all teachers aren't willing to Come back, does that delay the process? Are you offering options for the teachers who don't feel Comfortable, safe or

Need to stay home because a family member is at risk so it doesn't delay the opening process?

It's very discouraging to hear other local public schools have staff preparing to go back and have also contacted parents with possible days their students may be back on campus if they open up in October. These schools are setting up a plan based on their waiver approval and or when the county moves to red tier and we haven't heard any plans or updates from

BUSD.
